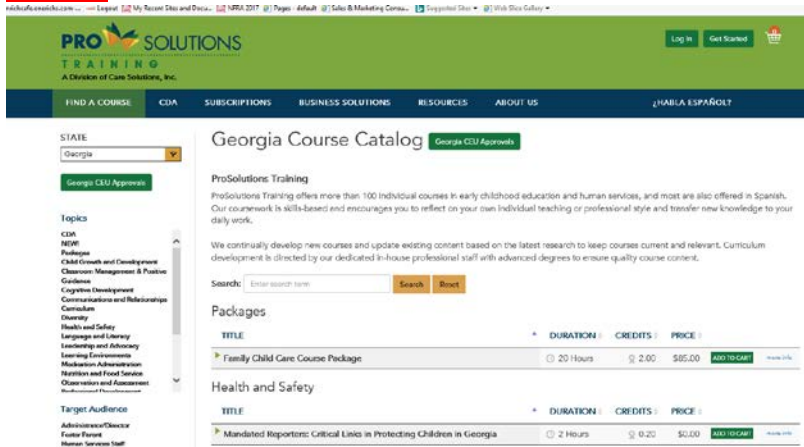

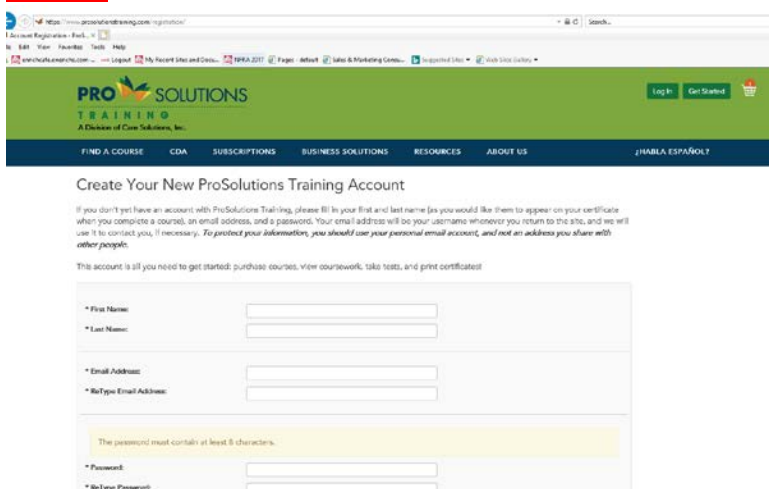

Course Features

What you need to know - as easy as 1-2-3!

1. You will move through the screens in this course at your own pace – stopping and starting if you wish.
